#### Interest groups:

We need to set up the structure for the interests groups – how can they be used properly? The board will discuss it further.

## 5. Discussion on proposals

- ITE Museum's proposal (to remove the maximum period of 4 years in the board) has been approved. More than half of the member organisations with the right to vote were present. EAO statutes, § 6.01:

The association will be lead by a board of min. 5 and max. 7 members. Board members sit in the board for 2 years. All board members can be re-elected although 4 years in a row is the maximum.

## 6. Decision on strategy, activity plan, budget and membership fee

- Website we would like to improve it and make it more informative. INUTI has offered to look into the improvements. However, we need funding to improve it properly or even design a new website. Also the Interest Groups should be presented on the website.
- Facebook page by EOA is available as a free informing channel for the members' activities. The secretariat will remind the members.
- Funding we need funding for the association to obtain its objective and provide the service we are aiming for. Ideas to funding opportunities are welcome. The EU application from last year is available for further development. We got a good score, just need to adjust it to the lacking points and the new EU programme.
- Activity report for fundraising and applications (demonstrates we are an active network) develop a report of what we are doing for the network events, conferences, travelling exhibitions, etc.

- Discussion: membership fee for individual members – is the fee too high? The board will look at it and set up a proposition for the next AGM. Until then the membership fee will continue as it is now (organisations: 75 euro, individual: 30 euro)
