Chiara from Galleria GliAcrobati shared news about creating a virtual outsider art gallery in Italy and suggested to collaborate with a yearly EOA exhibition in connection with the conference.

Raija from Association for Rural Culture and Education shared their work with online presentations of environments, that are not possible to visit in person. And also as a way of documenting environments after the death of the artist.

Anna from GAIA Museum shared news about the Erasmus project "Inclusionary – Art for Social Inclusion". GAIA is involved and would like to reach out to EOA members especially from studios and ateliers regarding specialist knowledge and best practice examples.

Monika from the open art museum talked about the museum's digital transformation. From next week it will be possible to visit the collection from the website. Monika suggested this could also have international perspectives and a way to visit each other's collections online.

Pierre from Community Arts Council Vancouver talked about a pilot project bridging different institutions – e.g. graduate students from design and art – in order to learn to make presentations more interesting and accessible by using plain language and to tell and perform instead of read to the audience.

It was suggested to follow up on these subjects in the coming EOA webinars.
